EXTENSION OF MARK PERMITS:

- **SANS 1086:2015:** Flexible poly (vinyl chloride) (PVC) pressure hose.
- **SANS 1156-2:2012:** Hose for natural gas and liquefied petroleum gas (LPG) Part 2: Hose and tubing for use in natural gas and liquefied petroleum gas vapour phase.

The SABS reiterates its commitment to providing effective and relevant conformity assessment services, and administering a dependable certification scheme to support the industry and thereby mitigate risks associated with product failure.

Over the last eighteen (18) months, anchored amongst others on its commitment referred to above, the SABS has strengthened controls in the conformance assessment services which play a pivotal role in certification scheme to SANS 1086, SANS 1156-2. Based on the outcome of the due diligence, the SABS has addressed various barriers (mainly external) that had a bearing on its certification processes, has streamlined its processes to better serve the industry and prioritized the conducting of audits and testing to the full specifications of SANS 1086, SANS 1156-2.

Consequently, while observing the SABS Mark Scheme Rules and in order to support the chemical industry, the SABS has resolved to implement the following, that:

- Expired permits be extended for a period of twelve (12) months reckoned from the date of approval thereof by the SABS Approval Board;
- The extension of permits referred to above, will only be granted upon verification that permit fees have been fully paid by the permit holder;
- During the twelve (12) months' extension period, audits and testing will be conducted to ensure that permit holders comply fully with the SABS mark Scheme Rules. Failure of permit holders to resolve non-conformances as per the certification rules will result in suspension and subsequent cancellation of permits; and
- After twelve (12) months, and if all the requirements of the SABS Mark Scheme Rules are met, the permits will be eligible for renewal for thirty six (36) months.
